



SWIMMING AND MEMBERSHIP FEES

After the initial assessment (trial) new members must complete the following before they are able to swim

1. Membership Forms and First Payment

- Complete the Marlborough Penguins Membership form (all sections please)
- Complete the Marlborough Penguins Health Questionnaire
- Email the 2 completed forms to membership@marlboroughpenguins.com
- Calculate your first months swim fees by adding together the Annual Membership fee of £41 (or £20 if joining Oct-Dec 2024) and first Months' swim fees (calculate using table below). Make an electronic payment for the amount to the Clubs bank account as follows: **Barclays Bank, Swindon, Sort Code 20-84-58, Account code, 43692108**
- Please complete the above steps within 2 weeks from the date of your trial, otherwise swim session places may be re-allocated.

2. Set up a Standing Order (SO) for the payment of monthly swim fees

- Set up a regular monthly SO payment between the 5th and 25th of each month for the monthly swim fees calculated using the table below. Please use a reference for your payment as follows "Swimmer's initial(s) Swimmer's surname, swim fees".
